Alongside his executive roles, David has developed extensive board and committee experience in banking, fintech, health, education and the arts. He has been Non-Executive Director and Chair of the Audit Committee at CIBC World Markets, Chair of Redwood Bank and Lead Independent Non-Executive Director of Fullerton Health in Singapore. He has also served as a member of the University of Manchester Global Leadership Board and as Deputy Chair, Honorary Treasurer and Chair of the Finance and Investment Committees of the River and Rowing Museum in Henley.
